In repose to the observation company has clarified that, "The Company was recently listed and the Company has already initiated the process of deployment of SDD software considering that the Company is using third party cloud infrastructure for its major data storage including it's ERP and as per SEBI Guidelines SDD software cannot be deployed with third party server (in cloud). The Company has also entered in formal agreement with Link *BSE Limited has conducted the onsite inspection of the Structural Digital Database (SDD) software. During onsite inspection BSE Limited raised clarification on SDD compliance. It was observed that the company was maintaining Structured Digital Database Software in non-tamperable Excel Intime Private Limited on 1st December 2022 to avail tools for SDD deployment and for other compliance related to SEBI (PIT) Regulations." The said software was in operation from the month of February 2023 and same was informed to the BSE Limited
